FM Approvals has been made aware of a falsified FM Approvals Certificate of Compliance (CoC). The document (attached as Figure 1) is an image of the falsified CoC misrepresenting flexible sprinkler hose models as FM Approved. The CoC in Figure 2 was issued to our actual customer Hangzhou Ehase-Flex Co., Ltd. who is investigating the source of the falsified document.
