Hazard Involved:

As a result of the missing locking screws and sealing washers, the threaded flameproof joint is compromised and the unit no longer meets the Explosionproof and Dust-ignitionproof classifications described above, and may present a property risk for users.

IMPORTANT PRODUCT NOTICE

Requires Immediate Attention

We are writing to notify you of a potential issue with an AUMA product you have received. The AUMA products in question are actuator model numbers SA(R)ExC07.1, SA(R)ExC07.5, SA(R)ExC10.1, SA(R)ExC14.1, SA(R)ExC14.5, and SA(R)ExC16.1 in versions NORM with electrical connection type SE or KE.

Through routine QC inspection we have found that certain AUMA actuators may be missing locking screws and sealing washers associated with the 100mm X 135mm frame adapter. As a result, the threaded flame proof joint associated with these locking screws is compromised, and the unit no longer meets the explosion proof requirements for installation in an electrically classified location.

If you have any of the above mentioned actuator models, and the actuators are installed in an explosive environment, you must disconnect power to the actuator immediately. The actuator may still be operated via the manual hand wheel, but power must be disconnected from the actuator to avoid a potential hazard.
